Sub:- Appointment of Administrator for Baramulla CC Bank Ltd.

ORDER *No. 4-RCS/B&F of 2007*
Dated 11/05/2007.

Whereas, a Board of Administrators was appointed to manage the affairs of BCC Bank Ltd; Baramulla for a period of six months or till the elections are held which ever is earlier, vide this office order issued under endorsement No. BK-79/2756-63 dated 1/2/2003 and ;

Whereas, the Board of Administrators attained the **Functionary** status on 31/3/2004, completing the aggregate period as specified under the Act inserted vide transitional provision and ;

Whereas, in the meantime, vide SRO-1 dated 4/1/2005 amendments have been carried in the Cooperative Societies Rules governing conduct of elections, thereby casting the entire responsibility upon the incumbent managements to cause the elections conducted before the expiry of the term of office and ;

Whereas, the attention of the over stayed management has been drawn towards the legal mandate regarding the in time holding of elections;

Whereas, the conduct of elections has been avoidably delayed, inviting aspersions from NABARD the co-Regulator;

Whereas, the NABARD in their inspection reports have been persistently pointing out the lacunae with the constitution of the managements of the Bank and;

Whereas, the BCC Bank Ltd; Baramulla is presently in the process of revival, warranting continuous review on the part of the elected management.

Now, therefore, I Dr. G.N.Qasba, Registrar, Cooperative Societies, J&K, in exercise of the Powers vested in me under Section 29 (4) of the J&K Cooperative Societies Act of 1989 appoint

Sh. Javeed Ahmed Dar S/O Late Mohd. Yousuf Dar R/O Ladoora Rafiabad District Baramulla as Administrator of the Bank, with the following officers to assist the Administrator in the discharge of his functions and holding of elections at an earliest, viz. within next 90 days from the date of appointment.
