Whereas, the Hon'ble Minister for Agriculture and Cooperation has been pleased to hold a review meeting on the working of Cooperative Banks in this office on 31/7/2007;

Whereas, the Record Note of the meeting was accordingly issued vide this office endstt No. RCS/SS/Election/1467-68 dated 9/8/2007;

Whereas, the Hon'ble Minister while reviewing the working of the Banks, Managing Director State Cooperative Bank Ltd; Srinagar stressed the need for full time Administrator for the Bank till the election is held;

Whereas, the incumbent Board of Administrators of the Bank headed by the Divisional Commissioner, Kashmir was engaged in attending other important official matters, thereby, making it difficult to attend the affairs of the Bank on day to day basis;

Whereas, the State Govt. has decided to democratize the working of Cooperative Institutions through the conduct of elections to all such Cooperative Institutions where the same had fallen due;

Whereas, under the existing Cooperative Societies, Act and the Rules made there under, a responsibility has been cast upon the incumbent managements to hold the elections on their own;

Whereas, the existing legal frame work governing conduct of elections has further necessitated the need to have a full time management in office to perform the quasi judicial function;

Whereas, the Hon'ble Minister for Agriculture and Cooperation vide his No. referred to above has been pleased to order the appointment of Mr. Haq Nawaz an Advocate from Kupwara as Administrator of the J&K State Cooperative Bank Ltd; Srinagar till the election are held. The Administrator shall also be assisted by a team of officers from Cooperative Department and NABARD.

Now, therefore, I Dr. G. N. Qasba, Registrar Cooperative Societies J&K in exercise of the powers vested in me under Section 29 (4) of the J&K, Cooperative Societies Act of 1989 appoint Sh. Abdul Haq Khan S/O Kh. Barkat-u- llah Khan R/O Devar Inderbugh Kupwar at present J-18 , Govt. Quarter Jawahar Nagar, Srinagar as Administrator (Chairman) of J&K State Cooperative Bank Ltd; Srinagar in place of the existing Board of Administrators for the period specified under the Act, during which period the elections shall be caused conducted. The following team of officers shall assist the Administrator in the discharge of his functions.
