Whereas, pursuant to Govt. Orders referred to above, the freight claims of Cooperative Marketing Societies/Central Level Cooperatives on account of their transportation of decontrolled fertilizers viz DAP, MOP and NPK during the cropping seasons Rabi 2006-07 and Kharief 2007 were sent to the Department of Fertilizers GOI for reimbursement / settlement vide this office letters referred to above;

Whereas, the Department of Fertilizers Govt. of India vide their communications referred to above has settled the freight claims of Central Level Cooperatives / Cooperative Marketing Societies of both the Divisions, lifted by such category of Institutions from the Manufactures under authorization issued by this office as per the standing Govt. orders during Rabi 2006-07 and Kharief 2007;

Whereas, the position of freight claims lodged by such Cooperative Societies vis-à-vis the amount claimed is indicated in the Annexures "A" and "B" to this order;

Whereas, an amount of Rs. 10.20 lacs was authorized by the State Govt. for payment / release to the Cooperative Societies, / Central Level Cooperatives as transport subsidy during the financial year 2007-08 out of State plan vide Govt. order referred to above;

Whereas, the position of claims settled by the Department of Fertilizers GOI for both Rabi 2006-07 and Kharief 2007 is further indicated under Annexures "C" and "D";

Whereas, for the sake of brevity, the position of freight claims lodged for the seasons and settled by the GOI is further tabulated as under:

Whereas, Department of Fertilizers GOI has released the amount of settlement for credit of this office Account NO. 65019277243 with State Bank of Patialia Branch Jammu;

Whereas, an amount of Rs. 15606983/- and Rs. 5401667/- aggregating to Rs. 21008650.00 has been credited to the aforesaid account as per the Bank Statement;

Whereas, the amount of settlement (Rs. 1323675.00) in respect of the freight claim of Kashmir Apex Coop. Marketing Society Ltd; Wanabal for Khariief 2007 has directly been credited to the individual account of the concerned Cooperative Society;

Whereas, an amount of Rs. 7617064/- in total has accrued as difference on the claims lodged and the claims settled by the Department of Fertilizers GOI;

Whereas, an amount of Rs. 3808287/- is already available in the account with State Bank of Patialia on account of the difference paid to the Cooperative Societies on their freight claims in anticipations of claims settled;

Whereas, the amount recoverable / adjustable from the Cooperative Marketing Societies viz CMS Zamindar and Tehsil CMS Jammu on A/c of the amount paid out of State Plan has been deducted from the individual claims of such Cooperative Societies as indicated under the Annexures.

Whereas, the position indicating the amount of freight to be paid to the individual Cooperatives is further indicated under Annexures "E" Rabi 2006-07 and Kharief 2007, besides indicating the position of balance amount of Rs. 2532057/- which has been withheld for want of funds

Now therefore, sanction is hereby accorded to the release of the freight to the extent of Rs. 25663600/- in favour of the Cooperatives as indicated under annexure "E" and "F" to the extent shown against each (Col. total amount) through A/c payees cheques. However, amount payable to the Cooperatives listed under S.Nos. 19, 23 , 25, 29 , 30 32, and 33 for an amount of Rs. 1007736/- shall be paid out of the funds available in the official account of this office.
